## Dear Class Member:

As your school or school district was previously notified, the Asbestos School Litigation resulted in a settlement with certain asbestos manufacturers. Although you did not file a claim seeking reimbursement and the claim period to file for prior or future expenditures for friable asbestos in your building (for abatement, encapsulation, sampling and inspection), has expired, you are still a member of the class. As a class member, your school or school district has the limited right to purchase or otherwise obtain discount coupons from other class members.

As a part of the settlement agreements, W.R. Grace & Co. - Conn. Purchase Credit Coupons ("W.R. # INSTRUCTIONS ON USING THE GAF CORPORATION CASH REBATE PROGRAM

GAF Corporation and GAF MC ("GAF") will pay a "Cash Rebate" to any class member school or school district which purchases GAF products on or before December 31, 2005. A class member must purchase directly from GAF or indirectly through a contractor, distributor or sales representative within the United States (including the District of Columbia, the Virgin Islands, Guam, or any other territories or jurisdictions of the United States of America.)

GAF has the option to withdraw and terminate this Cash Rebate "Program" when GAF has paid Cash Rebates totaling two million one hundred thousand dollars (\$2,100,000.00) to Class Members. GAF must give written notice of the exercise of this option by first-class mail, postage prepaid, sent to each Class Counsel and filed with the Court.

Cash Rebates will be made within ten days of the end of each calendar year throughout the duration of the Program, i.e., by January 10 of each year up to and including January 10, 2006.

The Cash Rebates paid to class members during any one year period will not exceed \$350,000.00, over a seven-year period. If, at the end of each year of the offer, the total rebates due to class members is greater than \$350,000, rebates will be distributed to such class members pro rate, based upon the amounts of their purchases during the one-year period.
